*The sale of this Shih Tzu puppy is made upon the following terms and conditions:*

- \* The purchase price of this puppy is \$ \_\_\_\_\_ with full/limited registration. Shipping is an extra \$225 (price subject to change) which includes, flight, health guarantee and airline approved pet carrier. If requesting AKC papers there is a \$25.00 additional fee. Puppy must be paid in full by 7 weeks of age unless other arrangements are agreed upon and if not received the deposit is forfeited, contract is void, and the puppy will be placed back up for adoption. The deposit will be fully refundable if the puppy is not available due to some cause that is the fault of the seller. Deposits are NON-REFUNDABLE for any other reason. No refund will be given if buyer chooses not to complete the purchase of the puppy for any other reason.*
  
- \* As of the date you receive your puppy he/she has received age appropriate vaccinations and de-worming. Buyer has been given a vaccination record. This warranty does not cover hypoglycemia or diseases for which vaccinations could prevent.*
  
- \* To the best of seller's knowledge and belief, this puppy is in good health. No further health guarantee is made or implied. If the buyer believes this puppy to be sick, The animal should be taken to a veterinarian of the buyer's choice at the buyer's expense.*
  
- \* A one year Replacement Warranty from the date of birth is given for any life-threatening congenital disease not common to the brachycephalic breeds*

*that caused said puppy to expire.*

- \* A notarized Veterinarian Report with findings stating, to a medical certainty, that the death was in fact caused from the prenatal state will be required. Buyers will be required to send the notarized Vet's Report by registered mail along with all the puppy's medical records. Sellers Veterinarian must confirm and agree with the diagnosis. The Seller will then give buyer a replacement puppy of equal value and the same gender, from the next available litter. Replacement Warranty will be terminated if puppy was found to be abused, neglected, or does not have up to date records of vaccinations and fecal records or if the dog has produced offspring.*
- \* The seller will assume no shipping costs associated with the sale or Replacement Warranty.*
- \* We require that you take your puppy within 3 days of purchase date to a qualified vet for a wellness check up at buyer's expense and notify me immediately if your vet finds any problems with your puppy. If an injury, or accident caused by the buyer occurs or non- life threatening health issues including but not limited to kennel cough, worms, parasites, coccidia, giardia, pinched nostrils, cherry eye, under or over bites, hernias, and hypoglycemia that are common to the breed are not included in the health guarantee. All puppies are vaccinated, dewormed and treated as a preventative for coccidia and giardia with Gardiacox before leaving here.*
- \* Seller is not responsible for any veterinary costs of any kind once the puppy leaves her premises.*
- \* Registration fees are the sole responsibility of the buyer.*
- \* All monies are non-refundable.*
- \* Although this puppy may be of breeding or show quality, we sell our puppies only as pets. It is up to the buyer whether to show or breed. If a puppy is sold with full AKC registration rights, seller cannot guarantee the fertility of a male or female and it is not possible to guarantee breeding or show success. Limited AKC papers for puppies sold without full rights will be released after spay or neuter proof is received by seller.*
- \* Although we try to predict grown size and color, we do not guarantee size, color, etc. at adulthood....it is only an estimate based on seller's experience and traits of the parents.*
- \* Buyer agrees no charge backs will be filed through credit card companies or paypal on this transaction for any reason.*
- \* There will be no returns due to allergies, incompatibility, landlord's disapproval,*

*or inability to potty train.*

*\* The buyer promises to take good care of the puppy and shall not keep the puppy in a kennel, shall provide veterinary care when needed, keep in an environment that is suitable for a pet including proper food and water.*

*\* Any disputes will be litigated in Greene County, Missouri State, USA at buyers expense.*

If there is ever a reason that you need to return your puppy, we are HERE FOR YOU. Puppy must be returned at your cost. We will try and find the puppy a new home.
